Affiliation Agreement

Formation of the Agreement

- 1.1. This Agreement is made between the Administration of the International Peace Youth Group (hereinafter called "the IPYG") and Bhutan Youth for Peace Promotion (BYPP) (hereinafter called "the Affiliate") to unite in one purpose of realizing the vision of justice, peace, and security in the world by creating a new culture for all humanity.
- 1.2 IPYG is a youth division of Heavenly Culture, World Peace, Restoration of Light (HWPL), a peace organization, officially registered with the Seoul Metropolitan Government in accordance with the regulations of the South Korean Ministry of Foreign Affairs regarding non-profit corporations that transcends differences in culture, belief and religion to engage leaders and youth in sustainable and comprehensive solutions for peace.
- 1.3 The Affiliate is an organization that aims to promote peace in the world and that retains full autonomy, being governed by its own rules and regulations.
- 2.1 This Agreement forms the basis of the relationship of the IPYG and the Affiliate.
- 2.2 This Agreement supersedes any previous agreement between the IPYG and the Affiliate relating to the subject matter of this Agreement, whether written or oral.
- 2.3 The conditions of the Agreement agreed to herein between the IPYG and the Affiliate are the only conditions upon which they shall deal with each other except so far as expressly agreed in writing by both the IPYG and the Affiliate.

Joint Action Obligations

- 1.1. The IPYG and the Affiliate shall use their best endeavor, as far as possible, to carry out their obligations set forth herein.
- 1.2. Either the IPYG or the Affiliate shall not be liable for any failure to deliver or delay in carrying out its obligations arising from circumstances outside its control, including but not limited to fires, accidents, and natural disasters.
- 2.1 The Affiliate joins the IPYG to participate in and contribute to the events including, but not limited to, summits, volunteer activities, seminars, and collaborative projects organized or co-organized by the IPYG.

- 2.2 The Affiliate shall coordinate and facilitate activities in fields of common interest at least once a year through mutual consultation with the IPYG.
- 2.3 The Affiliate shall coordinate and facilitate Peace Walk once a year in commemoration of the proclamation of the Declaration of World Peace.
- 3.1 The IPYG and the Affiliate shall communicate on a regular basis to promote and ensure effective affiliation between them.

Intellectual Property and Confidential Information

- 1.1. All intellectual property rights produced from or arising as a result of the performance of this Agreement shall become the absolute property of the IPYG.
- 1.2. The Affiliate may use any work or materials created by the IPYG or the Affiliate pursuant to this Agreement after conferring with the IPYG.
- 2.1. The Affiliate authorizes the IPYG to use its logo on promotional materials and otherwise for the proper performance of this Agreement
- 2.2. The IPYG may use other intellectual property created by the Affiliate after conferring with the Affiliate.
- 3.1. The IPYG and the Affiliate shall hold and maintain in strict confidence all Confidential Information, shall not disclose Confidential Information to any third party, and shall not use any Confidential Information except as may be necessary to perform its obligations under this Agreement and except as may be required by a court or governmental authority.

Duration, Termination and Consequences of Termination

- 1.1. This Agreement shall commence on the date the IPYG communicates its acceptance of the Affiliation to the Affiliate and shall continue until one party gives to the other not less than one month's written notice.
- 1.2. The IPYG may terminate this Agreement with immediate effect by providing written notice to the Affiliate if:
- 1.2.1. the Affiliate commits any material or persistent breach of this Agreement;
- 1.2.2. the Affiliate fails to or refuses to perform its obligations in accordance with this Agreement; or
- 1.2.3. the Affiliate ceases to exist.
- 1.3. Upon termination of this Agreement:
- 1.3.1. each party shall return or, at the disclosing party's request, destroy any confidential information of the other party; and
- 1.3.2. the Affiliate shall permit the IPYG to continue to use the Affiliate's logo, or any intellectual property of the Affiliate on IPYG Materials printed or published or contemplated to be published for a period of 12 months;

General Provisions

1. This Agreement and the documents referred to herein contain the whole agreement between the parties and supersede any previous agreement between them relating to the subject matter of this Agreement, whether written or oral. The parties acknowledge that neither of them has relied upon any representation, written or oral, of any person but only as expressly set out in the Agreement.
2. The Affiliate shall hold and maintain in strict confidence all Confidential Information, shall not disclose Confidential Information to any third party, and shall not use any Confidential Information except as may be necessary to perform its obligations under this Agreement except as may be required by a court or governmental authority.
3. The Affiliate may not assign, sub-license or sub-contract the Agreement or any of its rights or obligations hereunder without the prior written consent of The Organization.
4. If any provision of the Agreement is declared by any judicial or other competent authority to be illegal, void, voidable or otherwise unenforceable, or indication of the same is received by either of the parties from any relevant competent authority, such provision shall be deemed severed from the Agreement and the remaining terms of the Agreement shall remain in full force and effect.
5. Any notice to be served on the other party shall be sent by recorded delivery, registered post, e-mail or fax. Notices sent by registered post or recorded delivery shall be deemed to be served within 72 hours of posting, and by e-mail or fax within 24 hours if sent to the correct e-mail or fax address of the addressee.
6. This Agreement is governed by and is to be construed in accordance with the laws of the Republic of Korea.
